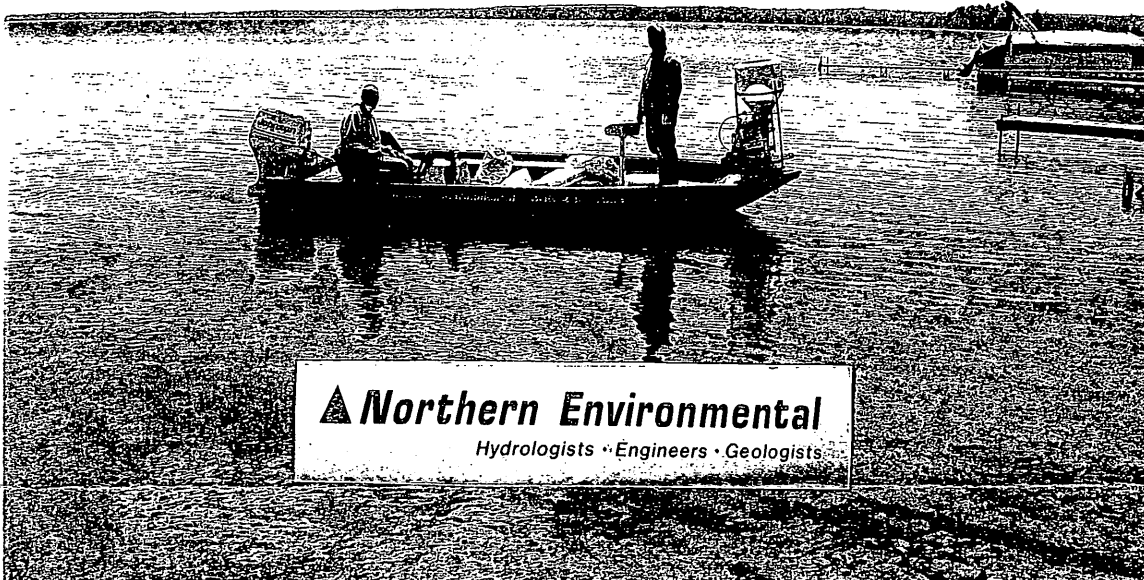

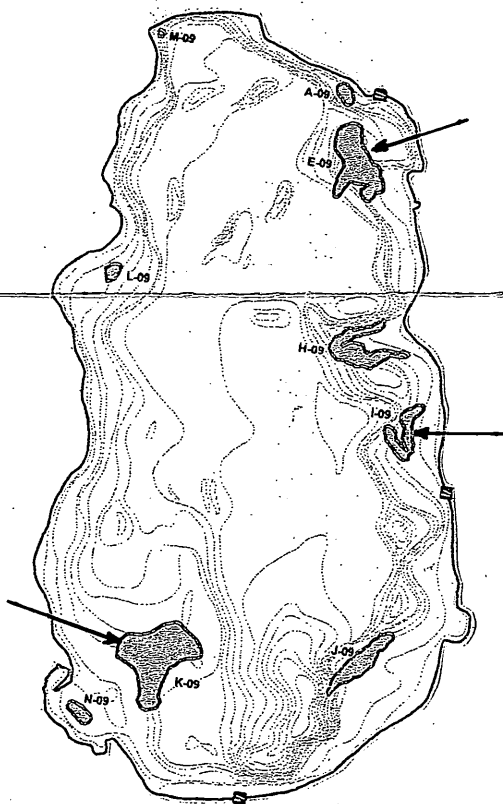
LEAVING THE BOAT LAUNCH - READY TO TREAT MILFOIL

CHEMICAL TREATMENT - Lake Metonga Association contracted with Northern Environmental (“NE”) to chemically treat the Eurasian Water Milfoil (“EWM”) beds in the Lake. A pre-treatment survey was done on May 22, 2009, by our consultant, Onterra LLC, to establish the location and GPS mark each EWM bed.

The survey compared data collected from the pre-and-post treatment surveys in 2008 to determine whether these beds were eliminated, decreased in size or actually increased. The amount of 2,4-D herbicide to be applied per acre is based on EWM bed density and water depth in which this aquatic plant is thriving.

GPS data from Onterra's survey is programmed into NE's guidance system to obtain a real-time mapping of the EWM beds. NE accurately applies 2,4-D over these mapped areas.

On May 27, 2009 NE treated 81.1 acres of EWM; 26 at 150 pounds/acre and 54.2 at 200 pounds/acre. The following map defines the treated areas.



Beds E-09, I-09, and K-09, marked by arrows, were treated with 200 pounds of 2,4-D per acre and the remaining 6 beds were treated at 150 pounds/acre. Onterra

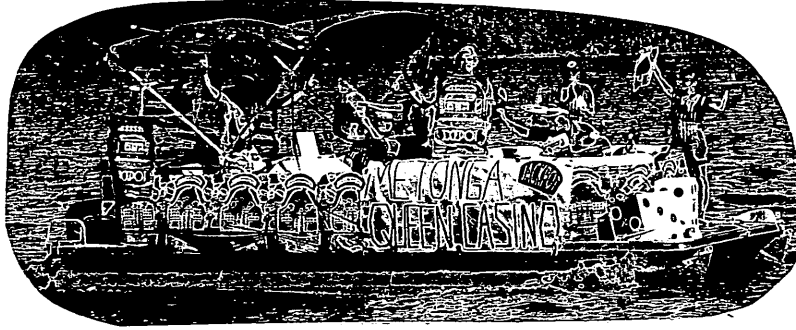
will survey the beds later in the season to assess the effectiveness of the treatment.

The cost to treat 81.1 acres is \$53,000.00. Les Schramm with the help of Vern Dvorak placed treatment signs on all Lake properties that are within 200 feet of the treated areas. Signs were stapled to owners docks and at both boat launches. NE agreed to reduce the price by \$500.00 since the Association did this posting.

The WDNR Chemical Plant Control Application and permit cost \$1,270.00 bringing the total cost to \$53,770.00 (\$52,500 + \$1,270.00). WDNR Grant ACEI-042 received in 2008 will fund 75% of this cost ($53,770.00 \times 0.75 = \$40,327.50$). However, the remainder of the cost which is \$13,442.50 is an expense of the Lake Association.

The membership fees, donations and raffles are the Association's sources of income. These funds support the Association's ability to respond to ecological changes in the Lake that may have a detrimental affect on the Lake's ecosystem.
