On January 21, 2019, the Lake Metonga Association was among twenty-five area organizations to receive generous donation and grant monies from the Sokaogon Chippewa Community at their annual awards reception hosted at the Mole Lake Casino Lodge-Conference Center.

The donations and grants came from the Tribe's gaming revenues and a special federal grant arranged by the Tribe's fisheries department. As part of the federal grant, the \$5,000 awarded to the LMA is earmarked specifically to fund a large portion our CB-CW program this year.

The special \$24,000 federal grant arranged by the Tribe's fisheries department will help fund CB-CW programs on five area lakes:

- Lake Lucerne Association
- Squash Lake Association

The LMA CB-CW program inspects watercraft at both boat launches throughout the summer. These inspections and the education of everyone using our lakes and rivers in Wisconsin is the most effective means available to help control invasive aquatic species, such as EWM (Eurasian Water Milfoil), which has now spread to over 900 water bodies in Wisconsin. Once established in a lake or river, it is virtually impossible to eradicate, so controlling its spread is imperative.
