# **Mueller continued...**

Fishing season opened a few days after the ice went off, to "Blue Bird Day". Sunny, warm and windy. Didn't hear of many legal walleyes being caught, but we did see countless undersized fish that kept fisherman busy all week. Hopefully, the lake will warm up enough to turn on the bite of a few larger fish. Tribal spearing was about 20% below allowable harvest with 887 fish taken. Bullhead control is on hold for now. We hope some harvesting can take place in early summer.

The Eagle Camera is very popular as the eaglet is getting big and more active (see page 4). Grocery shopping is good for the Eagles with a menu of duck, squirrel, walleye, crappie and sucker appearing daily in the nest.

Several Loons were active and checking out the nest in Peterson Bay. They finally set up housekeeping on May 12th. Calling practice — daily, at 2:30 AM — is just getting started. Mark Truyman and I reworked the loon platform the day after ice out.

# "Honoring Frontline Workers" 4th of July ALL BOAT ARMADA on Lake Metonga

Come one, come all. We've got 2,100 acres of lake space to accommodate all the social distancing you need! Decorate your boat or pontoon for a chance to win big prizes. Or, just join the parade as you are, and you'll still have a chance to win prizes — all of which will help support our local Crandon-area businesses.

#### **Parade Rules:**

- The ALL Boat Armada on Lake Metonga will go in a **CLOCKWISE** direction (note: this is the opposite direction from previous years).
- The procession is for one lap beginning and ending from your dock or point of origin beginning at 1:00 pm on Saturday, July 4. Please maintain a slow speed, safe distance from others boats, and reasonably close distance to the shore, so spectators can get a good look.
- To be eligible for a prize (decorated or not), on your way around the lake, swing by the dock at Charlie's to pick up your registration ticket. These will go into the raffle drawings for prizes, and used by the judges to select decorated boat contest winners. KEEP YOUR TICKET! Winning numbers will be published in Forest Republican newspaper and on the LMA website. <u>You must have your ticket to claim your prize</u>. Pickup location for prizes will be published with winning numbers.
- If you have a decorated craft, pass through the judging station by Goeman's dock on the south-west side of the lake (don't worry, you won't be able to miss it!). Please go slow and allow plenty of space so the judges can get a good look.

#### **Decorated Boat Theme**

In support of all the front line men and women in Forest County, in Wisconsin, in the USA and around the world, this year's boat parade theme is *"Honoring Frontline Workers"*.

If you'd like to decorate your craft to some other theme, that's OK, but you won't be eligible for the prizes awarded by the panel of judges.

The eaglet survived the mid-March snow storm that nearly covered the parent in snow while protecting the chick in the nest. If you were watching closely, you may also have seen numerous breakfast and dinner meals including walleye, bullhead, and an occasional squirrel, muskrat or duck.

While the chick continues to grow, it's expecting to fledge (take flight) between June 16-30th. At the time of fledging, it will be almost the same size as it's parents.

# Schramm Memorial Update

In April, 2015, the Lake Metonga Association lost one of its most important members, Donna Schramm.

For those new to LMA, Donna and Les Schramm were instrumental with the association's fight against invasives, and served as an integral part of our association's activities, including applying for grants, serving as board members and officers, and conducting lake testing, to name a few.

At her passing, the association received several significant donations in Donna's memory. These monies have been set aside from the association's general fund, as they are intended for special circumstances which promote the goodwill efforts of LMA consistent with Donna's dedication to the organization and the surrounding lake area community.

In 2018, the LMA made its first contribution from this fund to purchase new kitchen equipment for the Donna Schramm Memorial Kitchen in the Crandon Lions Club new picnic pavilion at the city park adjacent to the north shore boat launch.

Earlier this year, the LMA board approved another expenditure from the memorial fund to provide a

scholarship donation to Kayla Reed as she commences her college education. The scholarship donation is in recognition of Kayla's outstanding academic achievement thus far in life, and her devout environmental studies and activities including those specific to Lake Metonga.

Even though she has been too young to be an active member in the LMA until very recently, Kayla has for many years been very active as Lake Metonga's Loon Ranger. She has also

performed the annual water testing and clarity checks with her father, Grant Reed. Many of you are probably familiar with the Reed family, as Grant is a past president of LMA, and wife Kim, a past treasurer. The scholarship was granted in the amount of \$2,000 with the blessing of Les Schramm.

Future proceeds from the memorial fund will be made available for nonprofits, students and other individuals that demonstrate exemplary effort and dedication to the Lake Metonga habitat and its surrounding community activities in keeping with Donna's devotion to the same.

#### Lake Metonga History: Forest County Veteran's Memorial Park (South Beach)

Forest County's Forestry Department currently manages 14,876 acres of publicly owned County Forest Land for the purpose of sustainable forest management, wildlife conservation, and recreation. The Forestry Department also maintains Veterans Memorial Park, located on the south end of Lake Metonga, for both residents and visitors to the area.

Veteran's Memorial Park was authorized by action of the Forest County Board of Supervisors on August 7th, 1962. According to the minutes of the County Board of Supervisors, William Duff moved to adjourn the County Board meeting "until the County Board, as a whole, inspected the progress on the Park."

The Forest Republican followed up the visit to the County Park with an in-depth article on the management of the park and a photo of the County Board's impromptu visit.

According to the article, Mrs. Jospehine Spencer was the caretaker at the park seven days a week and reported that an average of 53 people a day stayed at the park

in July of 1962 and that no one complained about the dollar per night camping charge made by the county.

	Spearing appears to be done for the year, with no spearing activity for the last 3 days, so these are likely the final numbers for Metonga. The safe harvest limit was 1,094 walleye on Metonga this year, the tribe declared 1,039 fish and harvested 887 fish.
	Thanks for the report Greg
	The local "rumor mill" is going strong, (even Corona Virus can't stop some things). The word is Mole Lake Band stopped harvesting at 800+- But another Band finished off the quota and did it with several "out of slot" fish.
	Don't spend a lot of time on this but if you hear something factual let me know.
	We are getting reports of a big upswing in bullhead schools. I tried to reach Mike about bullhead harves but haven't heard back. If you hear anything about this let me know.

None of that is factual. Tribal harvest is very closely monitored, especially on the lakes with a large quota. All fish are measured, and for each 30 fish permit they can only have a maximum of 2 fish over 20°.
I know Mike is very busy with projects that we are working on, plus his hatchery operation. I am sure he will get back to you, just will take some time.
