

A. 2019 LAKE WATER QUALITY DATA: CHEMISTRY

Chemistry data was collected on Lake Metonga - Deep Hole. The average summer Chlorophyll was 1.9 μ g/l (compared to a Northeast Georegion summer average of 8.9 μ g/l). The summer Total Phosphorus average was 17 μ g/l. Lakes that have more than 20 μ g/l and impoundments that have more than 30 μ g/l of total phosphorus may experience noticeable algae blooms.



A. 2019 WATER QUALITY DATA: TROPHIC STATE




Overall Trophic State Index (based on chlorophyll) for Lake Metonga -**Deep Hole was** 40. The TSI suggests that Lake Metonga **Deep Hole was** oligotrophic. This TSI suggests deeper lakes still oligotrophic, but bottom water of some shallower lakes will become oxygendepleted during the summer.





ADULT WALLEYE

- Fyke Netting: 1,194 adults captured & fin clipped
- During Electrofishing <u>14%</u> of 80 captured <u>bore clip</u>
- Results yield an estimate of 7,627 adults (3.8/Acre)
- Estimate <u>99%</u> of adult Walleye <u>15"</u> or longer
- Largest 28.7" female






SMALL MOUTH BASS

- Not a primary target
- Sampling occurred prior to peak spawning
- Captured 12 Bass 8" or larger
- 92% (11) were 14" or longer
- Largest was 19"
- Captured one 17.6" Largemouth Bass







NORTHERN PIKE


- Not a primary target

 in length
- Largest was 36.2" female

- Not a primary target
- Captured relatively high numbers
- Measure a subsample to index size structure
- 8% of sampling were 8" or longer
- Largest was 12.6"

C. 2020 WALLEYE HARVEST FACTS



EMAIL DIALOG BETWEEN MUELLER AND MATZKE REGARDING SPEARING:

MATZKE: "Hey Gary, Spearing appears to be done for the year, with no spearing activity for the last 3 days, so these are likely the final numbers for Metonga. The safe harvest limit was 1,094 walleye on Metonga this year, the tribe declared 1,039 fish and harvested 887 fish."

MUELLER: "Thanks for the report Greg; The local rumor mill is going strong... The word is Mole Lake Band stopped harvesting at 800+. But another Band finished off the quota and did it with several 'out of slot' fish. ..."

MATZKE: "None of that is factual. Tribal harvest is very closely monitored, especially on the lakes with a large quota. All fish are measured, and for each 30 fish permit they can only have 2 fish over 20"..."

- 5. FOLLOW-UP PLANNING: After the board gives final approval the committee begins planning related work (if necessary)










D. LOON REPORT
